Sub.: Issue of Births and Deaths Certificates available on Central Server/State Repository by a Registration Authority of any jurisdiction across Goa.

The Government has decided to make available the copies or certificates of Births and Deaths of all the citizens on the Central Server/State Repository so as to ensure easy availability of these documents on demand anywhere in Goa irrespective of any jurisdiction across Goa.

The copies of Certificate of Birth and Death means a copy of the certificate which has already been issued at the time of occurrence of the event or immediately after the occurrence of the event by a Registration Authority in his jurisdiction. The Birth and Death Certificates which are issued by the registration authorities concerned initially at the time of occurrence or after the occurrence of the event as the case may be and which are issued as a result of registration of the event are beyond the scope of this notification.

In other words, once a Certificate of Birth and Death has been prepared and issued to a citizen upon occurrence of the event, the copies of such Certificates of Birth and Death can

be issued by any Registration Authority irrespective of the jurisdiction, in order to avoid much inconvenience recently causing to the Goan Citizens.

All the Registration Authorities at all the Municipalities/Panchayats in Goa should, henceforth issue copies of Certificate of Birth and Death which have already been registered, to a Citizen on demand irrespective of the jurisdiction. These Registration Authorities should download such Certificates of Birth and Death from the Central Server for the purpose.

First Amendment of "Scheme to provide Financial Assistance to the Self Help Groups"

Whereas vide Notification No. 82-7-07-08-SDB dated 18th December, 2007 published in the Official Gazette, Series I No. 40 dated 3rd January, 2008, the Government of Goa framed the Scheme, viz. Scheme to provide financial assistance to the Self Help Groups (hereinafter called as the "said Scheme").

And whereas the Government has decided to amend the said Scheme.

Now, therefore, the Government of Goa hereby amends the said Scheme as follows, namely:—

1. *After the clause Financial Assistance following new clause shall be added.— (a)*

Not more than one member of the Self Help Group to be assisted under the Scheme shall be a member from the same family.

2. *The existing Eligibility clause shall be substituted by following clause.— Eligibility:- (1) The SHG should have valid Registration with the Competent Authority, at least six months prior to the date of application under the Scheme.*

3. *After the Eligibility clause, sub-clause (2), following clause shall be added.— (3) The contribution of the Self Help Group shall be 10% of the project cost as seed capital and 90% of the project cost shall be sanctioned as subsidy, subject to a maximum subsidy of Rs. 25,000/-.*

4. Under the clause mode of application in sub-clause (3) the word "two" shall be replaced by word "One".

5. *After the clause Other terms and conditions below sub-clause 2, following new clause shall be added.— Evaluation:- The evaluation of the project shall be undertaken by the Directorate of Planning and Statistics and Evaluation, Government of Goa from time to time.*

6. *To the form attached to the said Scheme under Sr. No. 12(iv) following clause shall be added.— 12(v) Affidavit duly sworn by the Chairperson or Secretary of the Self Help Group on twenty rupees stamp paper, stating that subsidy benefit is not availed under any other Government Scheme for the proposed project and the Self Help Group is not a defaulter to any Financial Institution.*

This Amendment Notification shall come into force with effect from the date of publication in the Official Gazette.

In exercise of the powers conferred by sub-section (2) of section 140 of the Goa, Daman and Diu Town and Country Planning Act, 1974 (Act 21 of 1975) and all other powers enabling it in that behalf, the Government of Goa hereby makes the following rules so as to amend the Goa, Daman and Diu Town and Country Planning (Planning and Development Authorities) Rules, 1977, as follows:—

1. *Short title and commencement.*— (1) These rules may be called the Goa Town and Country Planning (Planning and Development Authorities) (Amendment) Rules, 2010.

(2) They shall come into force at once.

2. *Amendment of rule 14.*— In rule 14 of the Goa, Daman and Diu Town and Country Planning (Planning and Development Authorities) Rules, 1977, the following shall be substituted, namely:—

“14. *Manner of filing appeals under section 45 and section 52.*— (1) Every appeal under sections 45 and 52, shall be in writing addressed to the Chairman or the Member Secretary of the Board and shall specify the grounds of appeal and the point which the ruling of the Board is required.

(2) Every appeal, except made on the grounds applicable in the case of section 45(1)(b), shall be submitted in thirty hard copies and one soft copy, by—

(a) Copies of the application made to the Planning and Development Authority;

(b) Copies of all relevant plans, documents and particulars submitted with the applications;

(c) True copies of the order or notice of the Planning and Development Authority, as the case may be;

(d) Copies of all other relevant correspondences with the Planning and Development Authority.

(3) Every appeal, except made on the grounds applicable in the case of section 45(1)(b), shall bear a fee of rupees five hundred.”.

Whereas Hon'ble Finance Minister in his Budget Speech 2010-2011, has made a mention that every year an approximately 250-300 people loose their lives and equal number are injured, some with permanent disability and others with partial disability and more often than not, the deceased/injured happen to be the only bread earner of the family and not covered by any life insurance cover and in the event of death and disability of such persons, the entire family is disturbed emotionally, psychologically and financially.

And whereas Hon'ble Finance Minister has proposed to provide such families which are not covered by any insurance cover policy with a financial assistance of Rs. 2.00 lakhs in case of death, Rs. 1.50 lakhs in case of permanent disability and Rs. 1.00 lakh in case of partial disability.

And in order to fulfill the assurance given by the Hon'ble Finance Minister in his budget speech as well as for effective implementation of the assurance the Government is pleased to enact the following scheme:

(1) The scheme shall be called "the Goa State Interim Compensation to Road Accident Victims, 2010".

(2) It shall come into force with effect from 19th December, 2010.

(3) The scheme provides for financial assistance to the victims/families of victims who are not insured against accidental death or bodily injury caused by external, violent visible means in road accidents.

(4) The scheme covers the family of Road Accident Victims which will be paid financial assistance of Rs. 2.00 lakhs in case of death, Rs. 1.50 lakhs in permanent disability, Rs. 1.00 lakh in case of partial disability and Rs.15,000/- (Rupees Fifteen thousand only) per accident

victim who sustain minor injuries when there is no disability.

(5) The scheme provides for disbursement of compensation to the families of Road Accident Victims by the Transport Department on the basis procedure as at Annexure 'A'.

(6) *Explanations of Important Terms.*— (i) *Death:*— Death on account of accident on the spot or on account of any suffered injury within twelve preceding calendar months of the occurrence of accident, provided it be the sole and direct cause of the death.

(ii) *Permanent Disability:*— shall include—

(d) Loss of two limbs, two eyes or one limb and one eye.

(e) Loss of one limb or one eye.

(f) Permanent total disablement from injuries other than those named above and certified by the Medical Board of Goa Medical College and Hospital, Government of Goa.

(iii) Permanent Partial Disability shall include—

(a) Loss of hearing both ear.

(b) Loss of toes.

(c) Loss of hearing one ear.

(d) Loss of four fingers and thumb of one hand.

(e) Loss of four fingers.

(f) Loss of thumb both phalanges.

(g) Loss of index finger phalanges.

(h) Loss of middle finger.

(i) Loss of ring finger.

(j) Loss of little finger phalanges.

(k) Loss of metacarpals fifth or second (additional) third, fourth or fifth (additional).

(l) Any other permanent partial disablement as assessed by the Medical Board of Goa Medical College and Hospital, Government of Goa.

(iv) Beneficiary:—

(a) In case of permanent disability or permanent partial disability the individual who suffers injury.

(b) In case of death of the individual head of his/her family.

(c) In case of death of the individual who himself is the head of the Family, his/her spouse and/or wholly dependent children.

(7) The eligibility criteria for availing benefit under this scheme shall be.—

(i) That individual victim of road accident should not be covered by any other Insurance Policy and/or, a scheme of the Government wherein compensation has been paid or which makes the beneficiary eligible to receive compensation.

(ii) Beneficiary must be a resident of Goa and shall attach proof of residence such as voters ID/Senior Citizen Card or Residence Certificate issued by the Competent Authority alongwith the claim.

(8) *Procedure for claiming the compensation.*—

(i) Upon the happening of any event which may give rise to a claim under this scheme, an application on the prescribed proforma with full particulars must be given to the Director, Directorate of Transport within a period of 30 days of the happening of such event.

(ii) Satisfactory proof to the Government shall be furnished of all matters upon which a claim is based.

(iii) Medical or other authorized person of the Government shall be allowed to examine the injured person(s) to verify the nature of alleged injury or disablement if it is reasonably required by the Department for finalization of the claim.

(9) *Procedure for disbursement.*— Compensation under this scheme shall be disbursed by the Department of Transport, 1st Floor, Junta House, Panaji-Goa.
